

### James Gage and Family (submitted by Kevin Lee)

It is well known that what is now known as Battlefield Park was the original site of the James Gage farm, where a decisive battle in 1813 took place which forever changed our country. What is lesser known, except to the descendants of the Gages, is the family itself.



James Gage was born June 25, 1774, the son of Mary Jones and John (or James) Gage in Greenbush, New York. James' father was killed in the Revolutionary War although it is lost in history what side he was on, if he was Captain John Gage who fought for the British and died at the Massacre of Wyoming, or James Gage who died as an American private at Fort Clinton in 1777. Unfortunately, these records are lost in time

The death of her husband left widow Mary to fend for James and her daughter Elizabeth. Mary brought her two children to Lake Ontario in about 1790 to the area which is now known as Stoney Creek near her brother Augustus Jones, who was Chief Surveyor for the crown and between herself and son James applied for land grant for crown land. Widow Mary

Jones received a land grant on May 6, 1796 for 200 Acres, and James 175 Acres. The land acquired by Mary and James was next to land acquired by her sister Suzannah Jones, who married William Gage from Rathlan Island, Ireland, (John's brother), who also immigrated to the Colonies and later Stoney Creek.

James married Mary Davis (B. Oct 26, 1777 North Carolina, D. Oct 18, 1853 in Hamilton, Canada West, daughter of William Davis and Hannah Phillips of Mount Albion. James and Mary had 10 Children, many of them marrying into local pioneer families. Many of the offspring of these families went on to be successful pioneer businessmen and had a role in building up Stoney Creek, Hamilton and Burlington.

James, besides operating a store on his property, was also a successful businessman in other areas as well. In 1810 he purchased from the Brant family property in what was then known as Wellington Square, what is now Burlington, Ontario. He and his sons, Joseph, Andrew and Asahel, operated among other things a steam flouring Mill and a Warehouse and Wharf, and later numerous Lumber, Flour and feed Mills in Halton County. James and Mary lived in their later years in Hamilton, along with their daughter Mary and her husband A T Newberry. James passed away February 15, 1854, Mary almost a year earlier on October 18, 1853. Both are resting in Hamilton Cemetery on York Street in Hamilton, not far from the front entrance and offices.

Children of James Gage and Mary Davis:

Asahel Gage b. September 28, 1798 in Stoney Creek,

d. July 1, 1861. Married Nancy McCollum, had 9 children

Catherine Gage b. August 26, 1800 in Stoney Creek, d. April 02, 1871, in Stoney Creek, married William Freeman of Halton County, October 13, 1825, they had 9 Children

Andrew Gage b. February 9, 1802 d. June 29, 1876 in Wellington Square married Martha Willson Apr 21, 1824, they had 4 children

Elizabeth Gage b. January 25, 1805 d. May 12, 1892 married Lewis Dennick Birely on May 18, 1826, they had 6 children

James Philip Gage b. June 10, 1810 in Stoney Creek, d. April 02, 1883 in Lyons, Iowa, Married Mary Jane Davis November 24, 1836, they had 8 children

Ann Eliza Gage b. June 22, 1821 in Stoney Creek d. July 27, 1897 in Hamilton, Ontario, married Levi Beemer, they had 9 children

Sarah Gage, d. January 1, 1842, m John Galbreaith, they had one child

Keziah Gage married John Triller, they had two children

Mary Gage married A. T. Newberry, issue unknown

Joseph Gage married Alice Daniel, issue unknown

# STONEY CREEK HISTORICAL SOCIETY REFERENCE LIBRARY AND ARCHIVE NEWSLETTER JUNE 2013

In the last several weeks, we have had inquiries for the following: A fellow in Milton has restored a 2-team gravel wagon said to have been used by the Village of Stoney Creek circa 1900. He contacted us to see if we could confirm that information. We sent him a photocopy of a wagon photo that we have but it was not the same one. We have invited him to visit our site to view our holdings of minutes and bylaws from the early years to aid in his research.

We have been assisting a family who is researching the history of 1 Jones Street, Stoney Creek as well tracing the lineages of the families who have lived there. It is their hope to restore this house and have it designated as an historical property.

A year ago we provided family information to a woman who is researching the Gage/Olmstead families and we were recently able to answer a second request from her.

As always, if you have information or photographs that would help us in our research, please contact us.

We were invited to join with the Niagara area Historical Societies to share information (both historical and operational). We have already discussed various methods of recording family histories, including personally entering data for wills, land purchases and sales; buildings, crops grown. Historical Societies included are Grimsby, Lincoln, West Lincoln and Stoney Creek. Their hope is to join forces for ordering purposes. There are only two suppliers for Archival materials and shipping charges are often more than the small order placed.

We have already met in January and April at Grimsby Historical Society. We will be hosting the next meeting June 13 at 605 Hwy. No. 8.

Ross Garry is progressing at a very good rate photocopying all of the newsprint in our files. The family records are finished and Ross is working with all of the Stoney Creek business and Church files that we hold. This is a continuing effort and we could not manage without the help of Ross Garry. Larry Mitchell and Peter Kennedy are well on their way to completing the photographing of the Land Registry Ledgers. If you joined us at our Open House in January, you would have seen the method used.

By the time this Newsletter is delivered, we will have our own digitized records of the Minutes and Bylaws for Stoney Creek and Saltfleet. We purchased the reels from the Ontario Archives last year and the City of Hamilton records department, under the direction of Lisa Barroso, has prepared them for our use.

It is our hope that all of our volunteers will continue to progress at this rate. It will mean that we will have even more records, photographs and information available to assist with inquiries. Anyone who would enjoy helping us is welcome to come to the Reference Library to speak with us.

We invite everyone to stop by Tuesdays and Thursdays from 1 p.m. to 4 p.m. to view our Reference Library and Archive.

### THE **GAGE HOUSE** AT THE TIME OF THE BATTLE:

### WAS IT A LOG HOUSE OR WOODEN FRAME?



If the Gage house not built till 20 years after the battle as some suggest.

Why are the beams hand hewn when Adam Green had a saw-mill in operation at the time of the battle?

The hand hewn beams would suggest this house was built long before the battle.

**In 1974, Stoney Creek News** showed pictures of the house renovations and the original one storey house had hand hewn wooden beams (logs) coming up about four feet through the now second floor, so the original ceiling in the one storey was much higher and could have had a loft. Maybe the hand hewn was Elizabeth's interpretation of logs?

**Elizabeth Gage Birely** who was 8 at the time of the battle says in a June 12 1889 interview in the Hamilton Spectator that her father's house (James) was a log house and American officers stayed there.

Did she say log house or was that a misprint by the Spectator? Did she say log house meaning it was a wooden house versus stone or brick like she lived in now?

76 years after the fact how reliable is Elizabeth's memory at 8 years old? She never said in an 1852 interview anything about the house being logs. Nowhere else have I read that the family hid in the loft; all have said the cellar. That is before the 2003 book called

(Stoney Creek the Skeletons in its Closet)

**Elizabeth** also said in this newspaper article that the Americans took 20 barrels of whiskey from the cellar but James Gage her father only claimed for 10 gallons taken in his official request for compensation. Elizabeth also said the American soldiers killed all the cows and sheep they could lay their eyes on. James Gage only claimed for 3 calves and 1 sheep.

**James Gage** claimed also for "3 rooms in my dwelling house occupied as barracks by part of the 100<sup>th</sup> Regiment, 54 days at 5/ per day Oct to Dec 1813 ( *3 extra rooms in rough hewn log house*?)

He also claimed for the use of the barn and 2 out houses ( store and original log house ? )

**Elizabeth's** account has the summer wool kept in the loft and they hid there. Why would they hide in the loft if a stonewall cellar was available? ( *oops full with 20 barrels of whiskey* )

Was it Elizabeth's memory that was playing tricks on her after all those years or was it the misinterpretation of the Spectator reporter? (maybe a little of both)

**Robert Waddell** son in law of Elizabeth said General Winder & his staff stayed in the Gage house.

### **Emerson Bristol Biggar states in his books** (1873 and 1893)

Adam Green's "water power saw-mill which supplied lumber for several dwellings that were erected or were being built in the neighbourhood. Among these James Gage's house and store, still standing on the site of the battle ground were of quite respectable dimensions so much so that they were appropriated by the two American generals and their staffs as head quarters for the night, while Gage and his family were relegated to the cellar"

"Generals used Gage house as headquarters" In Biggar's 1873 version "General Winder was captured by Major Ogilvie coming out of the Gage house" Would the American Generals be using a log house for their headquarters?

"The road which was not graded at the hill as now" suggests this is a new road cut straight through along the concession line from the bridge in downtown Stoney Creek. Where as the original Indian path (road) turned up going south of the Gage house, went south of the cemetery and curled back before the ravine on the south side of king st and nash road. (on high ground to remain dry and not through the cedar swamp recently cleared.)

Why would the Gage house be built facing the south if the main road was always to the north. If the house was not built before the battle why wouldn't they have it built facing the now main road King street to the North. How many old farm houses were not built facing the road? (front door entry to stairs up to second floor, back door to cellar steps)

### Accounts in Souvenir book and programme when renovating in 1900 era


"Since the Women's Wentworth Historical Society has commenced to renovate the old Gage house, many marks of the battle have been found. In one corner of the porch a hole made by a five pound cannon ball has been found, and in one of the beams of James Gage's old store a spent cannon ball has been discovered"

"The late Daniel Dewey, who died in 1887 at the age of ninety years, came to Canada from the United States in 1818, five years after the battle. In coming from Niagara to Hamilton he stopped to examine the battle field. His children have often heard him describe the place as it was then. He found bullet holes in the Gage house and also in the trees and fences and said the house and surrounding plainly showed the effects of a severe fight and no other house in the vicinity showed any marks of the struggle"

**The Gage's commodious farmhouse** became the principal stopping place for travellers by land between Niagara and York. Over the years prominent Methodists, including Elizabeth Field and itinerant preachers such as James Coleman; starting in the late 1790's William Case, Joseph Sawyer and Nathan Bangs. Reverend William Case made his headquarters at the commodious house of Mr James Gage and stayed there quite awhile around 1821 according to the book "Case and his Contemporaries"
